Dear Principal,

This refers to your letter No. IHMCT/Malpractice/Exam-2018-2019/114 dated 16.05.2019 indicating that sixteen students have impersonated the signature of the faculty-in-charge Ms. Sathiya, Asstt. Lecturer in the journal book of Foundation Course in Food & Beverage Operations – BHM152 of SEM-II of 3-year B.Sc. in H&HA of 2018-2019 academic session, examination for which was held on 09.05.2019.

As per provisions contained in the examination rules, opportunity of personal hearing was provided to all the sixteen candidates to depose before the Examination Committee on 28th June 2019. While one student viz. Mr. Nanak Khurana, Roll No. 1841212036 deposed before the Examination Committee on 28.06.2019, eleven students sent in written representation and four were neither present nor sent written representation.

The Examination Committee after deliberation, decided to declare fail all the sixteen students in the practical subject of Foundation Course in Food & Beverage Service of SEM-II of 3-year B.Sc. in H&HA during the academic session 2018-2019. The committee was also of the view that a warning letter may be issued to all the students not to repeat such malpractice in future. Their signatures may be taken on the warning letter.

Decision of the Examination Committee may accordingly be communicated to all the sixteen candidates and their parents, under intimation to the National Council.

As per provisions contained in the examination rules, opportunity of personal hearing was provided to the candidate to depose before the Examination Committee on 28th June 2019. Mr. Yaksh T Gandhi, Roll No. 1841212013 was not present, however, sent a written representation. The Examination Committee after perusal of the confiscated material, report of the institute, decided to award punishment in terms of Examination Rule No. 9.2. (a) which stipulates that 'a candidate found having in his/her possession or accessible to him/her papers or chits or material relating to the subject of the question paper shall be declared fail in the subject'.

Mr. Yaksh T Gandhi, Roll No. 1841212013 is thus failed in the subject of Communication-BHM109 of SEM-II of 3-year B.Sc. in H&HA during the academic session 2018-2019.
