Sir/Madam,

The Council in its earlier communication informed/instructed to all the Institutes that newly admitted students for academic year 2020-21 will do the physical reporting on 5th October 2020 at the respective Institutes as well as opt for hostel accommodation. It was also informed that online hostel allotment will be made on 6th October 2020 and the physical academic activity for the new batch will be started from 7th October 2020.

However, the matter has been reassessed in the Council in terms of the inter-state travel restrictions still in force in different states in the country due to covid19 situation. Considering all these facts, approval of the competent authority of the Council is hereby conveyed to keep the physical academic activity from the campus under suspension till 1st November 2020. However, online induction as well as starting of academic program for the 2020-21 batch should be started by the respective Institutes between 7th & 10th October 2020. The Institutes who are in process of filling up of residual vacancies for more than 50% of the total intake may reschedule the induction and online start of academic program bit late but not later than 28th October 2020.

Tentative schedule for physical reporting of the new batch in the college has been fixed as 2nd November 2020 but that is also subject to the permission of such activity by the central government as well as concerned state government on the basis of local situation of covid19. Accordingly, the Council will provide contact details of the students admitted in the respective Institutes to enable them to communicate the students about their induction program as well as schedule for online classes. Since the physical reporting of the new batch has been postponed from 5th October 2020, it has been decided to shift the date of giving option for hostel by the students till they are physically reported in the Institute. However, the hostel seat matrix of each Institute for the new batch has already been publicised in the counselling portal to make aware of students about the seat availability in hostel.

Institutes may act accordingly.
